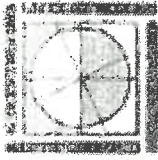

**NOTICE – ELIGIBILITY LIST FOR SPOT ROUND – II PG ADMISSIONS 2023-24**

1. The applicants, as indicated in Annexure I to VIII, are eligible to appear for Stage II related to the SPOT ROUND – II Process for PG programmes at SPA Vijayawada. Candidates, who were screened and eligible in Stage I, are allowed to appear for Stage II (Interview). Annexure IX is indicating list of ineligible.
2. All 'eligible' and 'provisionally eligible' applicants as indicated in Annexure I to VIII are required to report to the SPA Vijayawada campus by 08.30 AM on 15<sup>th</sup> Sept 2023.
3. All 'eligible' and 'provisionally eligible' applicants are required to carry with them, all supporting originals documents (and one self-attested copies of the originals) related to their application in terms of educational background, marks for each semester, degree certificates, provisional degree certificates, valid caste and category certificates as per Central Govt format, identity proofs, date of birth, NOC, portfolio, etc, as per requirements of the application and advertisement.

Applicants indicated as 'provisionally eligible' require to produce necessary original documents and their copies as indicated in Annexure I to VIII, and get their applications verified between 08.30AM – 11.00AM. Interviews in Stage II of admission process for such candidates will be started only upon clearance, after verification is done.
5. Eligible candidates shall then proceed for Stage II (individual personal Interviews and assessment of Portfolio and SOPs) from 12.00PM onwards till 07.00PM on 15<sup>th</sup> Sept 2023. Applicants are advised to come prepared to be present in campus till end of 15<sup>th</sup> Sept 2023 to complete the Stage II.
