SPAV Students Council Elections 2025 Phase II - Notification

Sub.: Notification for SPAV Students Council Elections 2025 – Phase II

Ref.: Approval of Student Council Elections by the Competent Authority vide subject file

Elections to the Students Council 2025 were held on 29.01.2025 and the Council members took charge on 31.01.2025 during INYAN 2025. As Nominations/Eligible Nominations were not received for 2 Positions, namely *General Secretary* [Position S.No. 3] and *Hostel & Mess Secretary (PG)* [Position S.No. 8], it is proposed to conduct Elections for the said vacant positions.

S.No.	Terms & Conditions
1	Voting shall be in person unless otherwise specified (online/offline as per the Returning Officer team)
2	All Students are eligible to Vote
3	A Candidate (Contestant) should not have any pending backlogs / academic arrears for any subject at the time of nomination for Student Council Elections.
4	A Candidate (Contestant) should not have any Fees due whatsoever towards the Institute, Hostels, etc. at the time of nomination for Student Council Elections.
5	A Candidate (Contestant) should not have been declared ineligible to appear for the regular exams in any subject/s due to shortage of attendance and/or shortage of Internal Marks in the preceding two semesters at the time of nomination for Student Council Elections. <i>Same is with the Proposer and Seconder for the Candidate</i>
6	Decision of the Returning Officer will be final and binding throughout the entire process given in Table 3
